#### ORDINANCE 3643

An Ordinance Adopting Amendments to Chapter 33 of the Code of Ordinances of the City of West Carrollton Known as "Administration," to Reflect the Current Organization and Responsibilities of the Service Department and Planning and Community Development Department. (1st reading)

Chief Code Enforcement Officer Enterman informed Ordinance 3643 proposes amendments to Chapter 33 titled, "Departments Boards and Commissions." A review of Chapter 33 was completed by staff and certain updates and amendments were deemed necessary to reflect the current organization and responsibilities of both the Service Department and the Planning and Community Development Department.

Proposed amendments include deleting §33.24 which assigns the Service Director supervision of the Division of Building and Zoning Inspection, which is currently the responsibility of the Director of Planning and Community Development. Section 33.25 is to be deleted at the request of the Finance Director as this is no longer necessary. Section 33.70 would be amended to reflect the Director of Planning and Community Development's current supervision responsibility for the Divisions of Code Enforcement, as well as the Building Inspection and Zoning Administration.

Proposed updates include adding new §33.72, thereby establishing a division of Code Enforcement; adding a new §33.73, thereby re-establishing a division of Building Inspection; and finally, adding a new §33.74, thereby re-establishing a division of Zoning Administration.

#### ORDINANCE 3644

An Ordinance Adopting Chapter 58 of the Code of Ordinances of the City of West Carrollton Known as "Public Works Code Administration and Enforcement," Which Establishes Powers and Duties Necessary to Properly Enforce Chapters 50 Through 57 to Include Chapters 92 and 97 of the Code of Ordinances of the City of West Carrollton Through the Division of Code Enforcement. (1st reading)

Chief Code Enforcement Officer Enterman informed this ordinance is seeking Council's approval to establish enforcement and administrative powers of the Public Works Codes to the division of Code Enforcement.

#### REPORTS BY OFFICERS

Mr. Townsend informed staff opened bids for the 2019 East Dixie Drive resurfacing project which is on the East end from St. Rt. 741 (Springboro Pike) to Dryden Road. The apparent low bid was submitted by Barrett Paving in the amount of \$284,785.50. Unfortunately that is about 4.9% over was our estimate was and this is because the price of asphalt has gone up as well as an estimating error on our part due, about \$7,000, due to underestimating the cost of maintaining traffic as this is a busy intersection. Overall we think it's a good bid and our Service Director is recommending we proceed with this project. The project is scheduled to begin on March 15th and should be finished by August 16th but we don't this it will take that long. As the date gets closer we will put out information maybe in our newsletter. We will be doing this under traffic so this will cause a significant amount of backups and delays and we ask that people use alternate routes to get to their destinations as the construction proceeds. Funding for this project is in two forms, around \$190,000 is coming from Federal STP funds through MVRPC the other \$94,000 is coming from the County Permissive Tax which is a portion of our license plate fees as administered by the County.

Mrs. Mattingly gave community updates:

• CSX railroad came in on Thursday February 21st and closed down Farmersville-West Carrollton railroad tracks for repairs. Our estimate shows they should be finished by Thursday, February 28th possibly as late as Monday, March 4th.
