A Resolution Authorizing the City Manager to Enter into a Contract with FCS Construction Services Inc. for the Demolition of Nuisance Structures and Restoration of Property Located at 38 N. Walnut Street.

Mr. Townsend informed that they recently opened bids for the demolition of 38 N. Walnut Street. This is to be funded as part of the Community Development Block Grant program. Ordinarily the resolution would come at the beginning of the year and you would authorize us to bid it out and we would announce the results. However, this one fell through the cracks. So instead of doing it that way we are asking that the contract with FCS Construction be approved as the lowest and best bid for the project. Mayor Sanner said it's a shame to demolish that structure, it used to be a Lutheran Church and was built in 1860.

REPORTS BY OFFICERS

Mr. Townsend informed on March 1st staff opened bids on the old West Carrollton Parking Lot Improvement Project. These are the parking lots in the Carrollton Center area and the Senior Center. This project was put off last year because the bids came in too high. This time we did receive a bid that was in perimeters although it's still a little over budget. Just like the East Dixie Drive project with asphalt prices up we are anticipating projects being a little over budget. However, the low bid came in at \$109,573 which is 6% over budget so we are within our perimeters. The bid we received last year, which we rejected, was over \$130,000 so compared to that it's a pretty good price. Contractor is JK Meurer Corp. and they have performed work for the Village of Mariemont, the Village of Wyoming, and Symmes Township so we are confident they will do a nice job for us and will get them started right away. The project should be complete by the end of May. Funding for that will come in the form of a block grant from the County. We are also putting together specifications for block grant proposal this year which will be sprucing up some of the landscaping in the old downtown area and that should be done before the end of the year as well.
