Your direction in accepting that report was the 3% adjustment be granted to all non-union employees. This amendment to the non-union wage scale would add another .5% to all non-union employees who previously received the 2.5% increase as well as the sergeants would also receive the additional .5%.

### **WORK SESSION**

## Disposition of Locust Street Property

Mike Lucking, Economic Development Director, informed council of a prospect company that wishes to either lease or purchase the City owned building at 31 N. Locust. The company is a non-profit organization that provides literary services to adults in the community. Lease term would be a 5-year agreement at \$6 per square foot or \$15,624 annually for the first two years, then \$7 per square foot or \$18,228 per year for the next three years through 2024. Improvements to the building in the amount of \$15,000 would need to be made to create classrooms for the organizations use that would come out of the first years rent. They would consider purchasing the property for \$99,000, through a third-party investor, but would prefer to lease it from the City. After a lengthy discussion on the pros and cons of leasing versus selling the property, it was the consensus of council to hang onto the asset and lease the property directly to the group. Mike will prepare documents for formal approval at a future council meeting.

### Police Trust Fund Purchases Request

Chief Woodard discussed with council a number of equipment purchases from the Police Trust Fund that he would like to make that were not part of the 2019 Budget. The Trust fund has seen a number of forfeitures from seizures effected from several criminal cases the past two years. The fund balance has grown to over \$200,000. Chief Woodard presented a list of needed equipment that the fund could pay for totaling \$50,000. These purchases would be in addition to the new \$45,000 camera system upgrade for the Civic Center that is being funded out of the trust fund. After a brief discussion, it was the consensus of council to authorize the Chief to proceed as proposed.

#### Other Business

Mr. Townsend informed council that he and Mr. Lucking had the opportunity to tour the former Friend Paper office building with an architect. The building, although cluttered, appeared to be in good condition. Mr. Townsend explained that an addition on the south side of the building will need to be demolished to accommodate the new sand volleyball development, but the remainder of the building could possibly be renovated. Mr. Townsend explained that once the demolition of the addition is completed and the building cleared of clutter, the architect will provide a more thorough top to bottom inspection to determine the feasibility of renovating the remainder of the building or demolishing it.
