## Residential Housing Infill Project Proposal - Craig Kellogg, Agro Realty Group

Mr. Lucking introduced Mr. Craig Kellogg, owner of Argo Realty Group. Mr. Kellogg presented a proposal to acquire and develop three City owned vacant residential lots and build new, owner occupied houses on each. Mr. Kellogg also discussed a proposal to acquire and renovate the City owned house at 323 E. Central (former Historic Society house). Mr. Kellogg presented information on his company, examples of other projects that he has compelled and renderings of homes that he would build on each lot. A copy of Mr. Kellogg's presentation is available upon request from the office of the Economic Development Director.

After a lengthy conversation, it was the consensus of council to proceed with Mr. Kellogg's proposal. Staff was directed to prepare the proper agreements and legislation for consideration at the next council meeting.

## Discussion - Point Broadband Fiber to the Home Project

Mr. Townsend informed Council of a new company that has made contact within City through MVCC about installing fiber to the home to each resident and business in the City. The company, Point Broadband, would install fiber optic data service in six of the seven MVCC communities beginning in the fall, with completion in 24 to 36 months. More information will be forthcoming as the project design is completed.
