Mr. Folker commented that serving on council is not a part-time job and should not be perceived as one and therefore is not a good thing to do.

Mayor Sanner commented that the timing of this ordinance is not good as we asked the residents to approve the permanent tax levy renewal instead of going to them every five years and they agreed to that. Now we are asking for a 25% increase in salary from \$3,000/year to \$4,000/year.

Mrs. Fryman commented that when she first was elected she was shocked that the finance director called her to come in to fill out tax forms. She had no idea she was getting paid to serve on council she ran for council to serve the community. Also the Charter Review Committee (a citizen group) looked at this about a year or so ago and they did not make any recommendations for changes.

ORDINANCE 3613

AN ORDINANCE DETERMINING TO PROCEED WITH THE LIGHTING OF STREETS, LANES, AND OTHER PUBLIC WAYS IN THE CITY OF WEST CARROLLTON, OHIO. (1st reading)

Mr. Reilly informed that we passed a resolution at the last council meeting and these are the follow-up ordinances that we annually have to do for the street light assessments. No increase in cost, about \$2.42/month for a home costing \$100,000. This is a housekeeping item we have to go through every year.

ORDINANCE 3614

AN ORDINANCE LEVYING SPECIAL ASSESSMENTS FOR THE LIGHTING OF STREETS, LANES AND OTHER PUBLIC WAYS IN THE CITY OF WEST CARROLLTON, OHIO WITH ELECTRIC LIGHTING. (1st READING)

Mr. Reilly informed this is the last step to levy the tax.

RESOLUTION 26-2017

A RESOLUTION AUTHORIZING THE CITY MANAGER TO PURCHASE WARNING SIRENS AND CONTROLS FOR THE CITY OF WEST CARROLLTON AND TO EXPEND A SUM IN EXCESS OF \$50,000 THEREFORE.

Fire Chief Barnett informed that the existing tornado sirens are about 35 years old and we have been awarded 50% match grant funds to replace those sirens. We were able to purchase those sirens at a reduced cost.

STATE BUDGET IMPACT

Tom Reilly, Finance Director, updated council on the estimated financial impact of the recently passed State budget. While many of the provisions of the budget are hard to predict, Mr. Reilly estimates that the conservative estimate is around \$50,000 per year. Mr. Townsend stated that there may be a legal challenge to the provision of the budget providing for a 0.5% collection fee for businesses filing through the State gateway program. After a brief discussion, council thanked Mr. Reilly for the report.

ECONOMIC DEVELOPMENT UPDATE

Mike Lucking, Economic Development Director, provided council with an updated report of Economic Development Activity in the City for the second quarter of 2107. A copy of Mr. Lucking's report is available upon request from the office of the Director of Economic Development.
