Ordinance 3654

An Ordinance Adopting Amendments to Chapter 90 of the Code of Ordinances of West Carrollton, Known as "Animals," to Include Sections 90.01, "Definitions," Section 90.061, "Cruelty to Companion Animals," Section 90.07, "Nuisance Conditions Prohibited," Section 90.19, "Community Cat Management; Permitted Acts," and Section 90.20, "Dangerous Dog Registration Certificate, Debarking Dogs." (1st reading)

Chief Woodard informed this ordinance has been updated to allow us to address situations where dogs attack other dogs and that attack causes serious injury to that dog. In the past the only way we could address that situation is if the attacking dog killed the other dog. That was unacceptable. The ordinance now allows us to take action if a dog attacks another dog and causes serious injury. The other part of the ordinance that was changed involved the cat program that coincides with the trap/neuter and release program which is county wide. The other changes are to support those two new chapters.

Mr. Robinson inquired about who makes the determination what "serious injury" is? Chief Woodard informed that the word "serious" is defined in our ordinances as well and if it's not clear at the time the judge could make that decision. Mr. Robinson inquired if a dog nips at your shoes or ankles would that not be considered a dangerous dog, is that correct? Chief Woodard informed, that is not exactly true. Initially if that is the first thing that happens with that dog, the dog would be declared a "nuisance" by the court then if something happens after that initial contact then the judge can declare that dog a "dangerous" dog. The dog doesn't have to bite someone to be declared dangerous, there is a process to go through. To be declared a "vicious" dog, under state statute, the dog would have had to kill or severely injure another dog or person. A judge can declare a "dangerous" dog "vicious." If the dog is declared "dangerous" the dog owner is required to obtain liability insurance. The county auditor will not issue a "dangerous" dog tag to the dog owner until proof of that liability insurance is shown. If the owner of the dog doesn't follow through with those procedures, the dog can be taken.

RESOLUTION 33-2019

A Resolution Amending Resolution 12-2019 Due to Withdrawal of the Approved Contractor, and Authorizing the City Manager to Enter into a New Contract with Plant Priority Services Inc. for the Demolition of Nuisance Structures and Restoration of Property Located at 38 North Walnut Street.

Mr. Gaines informed last year the city was awarded up to \$35,000 in CDBG funds from Montgomery County for the demolition of 38 North Walnut Street. In March of this year you approved 12-2019 which authorized the city manager to enter into an agreement with FCS Construction Services who declined to enter into a contract for this demolition. We are coming back to you with a new resolution which would authorize the city manager to enter into a contract with the next lowest bidder which is Plant Priority Services Inc. in an amount not to exceed \$34,005 which includes asbestos abatement as well.
