#### RESOLUTION 30-2018

A Resolution Strongly Opposing State Issue 1, Which is a Proposed Amendment to the Ohio Constitution that Would Weaken Ohio's Criminal Laws With Respect to Dangerous Drugs Such as Fentanyl, Heroin, Methamphetamine, Cocaine, and LSD.

Green City Demolition was the low bidder and is experienced in both large and small scale demolitions. They will take control of the property on or about November 1, 2018 and will secure a perimeter around the property. Green City will abate the limited amount of asbestos on site, sever all utilities to the three buildings, demolish the three buildings, close and fill existing wells on the property, crush

#### ORDINANCE 3639

An Ordinance Authorizing the City Manager to Enter into a Sales Agreement with SpikeIt L.L.C. of Cincinnati for the Purpose of Selling to SpikeIt L.L.C. an Approximate Seven (7) Acres plus/or Minus of Land Located at 200 West Central Avenue on the Land Parcel Commonly Referred to as Former Fraser Paper Property for a Sales Price of \$40,000 Per Acre for an Approximate Sales Price of \$280,000. (1st reading)

Mr. Lucking informed the proposed facility will consist of 44,000 sq. ft. that includes 9 indoor sand volleyball courts, food and beverage operation, and an area for spectators. There will be 8 outdoor sand volleyball courts, food and beverage operation, and seating for spectators as well as parking for up to 350 cars. SpikeIt has a target date for opening of October 2019.

The sale of the property also includes the transfer of the Friend Paper building to SpikeIt. Although SpikeIt owners do not have an immediate plan for the building they are willing to work with the City to explore future redevelopment options. The building will be taped off during construction to protect it. Mr. Roberts said he is open to suggestions on what to do with the building after SpikeIt is up and running. The City has also agreed to a one-year moratorium regarding the sale of the remaining former Fraser acreage to food and beverage operators. The moratorium will commence upon SpikeIt receiving their Certificate of Occupancy permit. The moratorium will expire 365 days later.

Jack Betts, partner, informed he and Larry Roberts, partner, and Mark Feathers, League Coordinator for Setters Sports in Dayton, are glad to be in West Carrollton. Mark will be the person who will run SpikeIt. Mr. Betts informed this is a big venture for them as they will be spending over \$4 million dollars and have spent over three years looking for land to build on, money, and people to go into this venture with. He gave a brief introduction about his background as well.

Mr. Roberts gave a brief presentation about the facility and what to expect. (See Mike Lucking, Economic Development Director for a copy of the presentation)

Mr. Robinson informed how happy the City is to have them here.
