## Ordinance 3711 (continued)

Planning & Community Development Director Gaines presented Ordinance 3711. He explained this is an application by the city that has two components. The first component is to amend the official zoning map to include a portion of the Olde Downtown District into our PUD. The second component is to amend the regulations of the PUD. Mr. Gaines gave a PowerPoint presentation that included maps, aerial views, and details of the proposed amendments. A copy of this presentation can be obtained from the Planning & Community Development Department.

Mayor Sanner asked Councilmembers if they had any questions for Mr. Gaines. There were none.

Mayor Sanner declared the Public Hearing open for public comment. He invited anyone who wanted to speak in favor of Ordinance 3711 to come to the podium with their name and address for the clerk's record. No one came forward.

Next Mayor Sanner gave anyone wishing to speak against Ordinance 3711 the opportunity to come to the podium with their name and address for the clerk's record. No one came forward.

Mayor Sanner closed the Public Hearing on Ordinance 3711. He stated this will be the first reading of this ordinance.

<u>Ordinance 3712</u> - An Ordinance Adopting Amendments To Chapter 154 Of The Code Of Ordinances Of West Carrollton: Zoning Code, To Permit More Than One Principal Building On A Lot In Certain Zoning Districts.

Planning & Community Development Director Gaines presented Ordinance 3712. He explained staff is proposing amendments to our zoning code to a provision that deals with the number of principal buildings on a lot in certain zoning districts. He stated staff has encountered some situations where this provision would limit the use of non-residential property. He explained staff and the Planning Commission believe this provision serves no purpose in terms of limiting the number of buildings for non-residential properties as long as the property or development can meet other zoning regulations such as minimum parking, building setbacks, landscaping, etc.. He also explained this could be an obstacle for our future development plans in the city as mixed-use developments always involve more than one building on a property.

Mr. Gaines gave a PowerPoint presentation detailing the proposed amendments. A copy of this presentation can be obtained from the Planning & Community Development Department.
