# Hope 4 West Carrollton Presentation - Rich Harmon

Rich Harmon, from Hope 4 West Carrollton, addressed Council and explained he was there to give a background on the organization. Mr. Harmon stated he is a full-time pastor of the West Carrollton Nazarene Church, a business owner, and is employed by the Miami Valley Leadership Foundation for his role as the Director as Hope 4 West Carrollton. In addition to giving some facts and figures concerning the operations of the group, Mr. Harmon mentioned the contributions of volunteers, including Lucas and Nicholas Van Ausdall and Aiden Theiss for committing to mowing yards for needy families at no cost. He also mentioned a six-year-old girl, Jasmine Chandler, who ran a lemonade stand this past summer. She took money that she made from her business and purchased care packages for the homeless in our community. Mr. Harmon stated he has been working alongside the Zoning Department to give them a resource to help people. Mr. Harmon mentioned their partners who include, Planting Seeds, Threads Clothing, Shoes for the Shoeless, CareSource, West Carrollton City Schools, The City of West Carrollton, MUM Food Pantry, Sinclair Community College, Bogg Food Ministries, West Carrollton High School Garden Program, Elder Care Connections, Valor Martial Arts, His Hope Addiction Recovery, Zion Lutheran Church, Memorial United Methodist, West Carrollton Nazarene, and Kettering Health Network. He encouraged Council to join them in some capacity.

Council thanked Mr. Harmon for his presentation and the fine work that their organization does for the community.

<u>Resolution 32-2022</u> - A Resolution Authorizing The City Manager to Enter Into An Agreement With The Ohio Department of Transportation To Repair Bridge Erosion Issues on IR-75 Over Holes Creek In The City Of West Carrollton.

Mr. Townsend explained that Resolution 32-2022 was requested by ODOT since they will be making repaired to a bridge that is within the city limits. This resolution gives ODOT permission for the project, which will be done at no cost to the city.

Mayor Sanner asked if there were any questions. There were none.

Mayor Sanner moved, seconded by Mrs. Tomlin to approve Resolution 32-2022. A vote was taken: Mr. Tilton-yes, Mr. Dobson-yes, Mrs. Tomlin-yes, Mrs. Zennie-yes, Mr. Barnhart-yes, and Mayor Sanner-yes.

Ordinance 3739 – An Ordinance Providing For Personnel Classifications, Rates Of Pay, And Working Conditions For Police Officers Of The City Of West Carrollton, Ohio, Authorizing The City Manager To Enter Into An Agreement With The West Carrollton Police Association (WCPA), Representing Said Employees, And Repealing Ordinance No. 3662 And Any Other Ordinances In Conflict Herewith.

Mr. Townsend stated that this ordinance would authorize the City manager to sign an employment agreement with the West Carrollton Police Association for rates of pay and other working conditions for the Police patrol Officers and Detectives. The agreement provides for five (5) percent cost of living increases each of the next three years, adds Juneteenth as a recognized City holiday, provides for a 5% plus rating for an officer that would be required to fill in as an Officer in Charge and provides for a \$100 per quarter cell phone allowance. All other terms and conditions remain unchanged. The agreement runs through December 13, 2025.

Mayor Sanner asked if there were any questions. There were none. This is the first reading of Ordinance 3739.

Ordinance 3740 - An Ordinance Providing For Personnel Classifications, Rates Of Pay, And Working Conditions For Police Sergeants Of The City Of West Carrollton, Ohio, Authorizing The City Manager To Enter Into An Agreement With The Fraternal Order Of Police, Ohio Labor Council, Inc., Representing Said Employees, And Repealing Ordinance No. 3663 And Any Other Ordinances In Conflict Herewith.

Mr. Townsend stated that Ordinance 3740 would authorize the City Manager to sign an employment agreement with the Fraternal Order of Police, Ohio labor Council, for rates of pay and other working conditions for police sergeants. The agreement provides for five (5) percent cost of living increases each of the next three years, adds Juneteenth as a recognized City holiday and provides for a 10% plus rating for a sergeant that is required to serve as Acting Chief of Police. All other terms and conditions remain unchanged. The agreement runs through December 13, 2025.

Mayor Sanner asked if there were any questions. There were none. This is the first reading of Ordinance 3740.

<u>Ordinance 3741</u> - An Ordinance Providing For Personnel Classification, Rates Of Pay, And Fringe Benefits For Employees Of The City Of West Carrollton, Ohio, Repealing Ordinance 3715 And Any Ordinance In Conflict Herewith.

Mr. Townsend stated that Ordinance 3741 provides for position classifications, rates of pay and other working conditions for all non-union employees. Mr. Townsend explained that this ordinance would crate five (5) new positions, while eliminating five (5) positions. In addition to these position changes, the ordinance would provide for a five percent (5%) cost of living adjustment and add Juneteenth as a recognized City holiday.

Mayor Sanner asked if there were any questions. There were none. This is the first reading of Ordinance 3741.
