A RESOLUTION BY THE COUNCIL OF THE CITY OF WEST CARROLLTON, OHIO REQUESTING THE AUDITOR OF MONTGOMERY COUNTY TO CERTIFY THE TOTAL CURRENT TAX VALUATION OF THE CITY OF WEST CARROLLTON, ENTIRELY LOCATED IN MONTGOMERY COUNTY, AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY AN 3.9 MILLS CONTINUING ADDITIONAL LEVY PROVIDING FOR THE SALARIES OF REGULAR FULL-TIME AND PART-TIME FIRE AND EMERGENCY MEDICAL PERSONNEL, INCLUDING THE PAYMENT OF ANY EMPLOYER CONTRIBUTIONS REQUIRED UNDER THE OHIO REVISED CODE, OR PROVIDING AND MAINTAINING FIRE APPARATUS, MOTOR VEHICLES, COMMUNICATIONS, AND OTHER EQUIPMENT USED DIRECTLY IN THE OPERATION OF THE FIRE DEPARTMENT, OR THE PAYMENTS OF COSTS INCURRED BY THE CITY AS A RESULT OF CONTRACTS MADE WITH OTHER POLITICAL SUBDIVISIONS IN ORDER TO OBTAIN FIRE PROTECTION AS AUTHORIZED BY SECTION 5705.19(I), OF THE OHIO REVISED CODE.

WHEREAS, the Council of the City of West Carrollton, Ohio, entirely located in Montgomery County, hereby declares the necessity of a continuing additional tax levy in excess of the ten-mil limitation in the amount of 3.9 mills in accordance with O.R.C. 5705.03(B)(1); and

WHEREAS, O.R.C. 5705.03 (B)(1) requires the City to request the County Auditor to certify a total current tax valuation of the City of West Carrollton and the dollar amount of revenue that would be generated by the specified number of mils.

NOW, THEREFORE, THE MUNICIPALITY OF THE CITY OF WEST CARROLLTON, STATE OF OHIO, HEREBY RESOLVES:

<u>SECTION 1</u>: The Council of the City of West Carrollton, in accordance with O.R.C. 5705.03 (B), requests the Montgomery County Auditor to certify the current total tax valuation of the City of West Carrollton and the dollar amount of revenue that would be generated by a 3.9 mills continuing additional levy.

<u>SECTION 2</u>: It is necessary that the additional tax be levied in excess of the ten-mil limitation for the purpose of Providing for the Salaries of Regular Full-Time and Part-Time Fire and Emergency Medical Personnel, Including the Payment of Any Employer Contributions Required Under the Ohio Revised Code, or Providing and Maintaining Fire Apparatus, Motor Vehicles, Communications, and Other Equipment Used Directly in the Operation of the Fire Department, or the Payments of Costs Incurred by the City as a Result of Contracts Made with Other Political Subdivisions in Order to Obtain Fire Protection as Authorized by Section 5705.19(I), of the Ohio Revised Code.
