AN ORDINANCE AMENDING CHAPTER 37: GENERAL FEE SCHEDULE OF THE CODE OF ORDINANCES OF WEST CARROLLTON, BY ADDING SECTION 37.38 MASSAGE SERVICES ESTABLISHMENT PERMIT FEES.

WHEREAS, the City Council has adopted Chapter 37: General Fee Schedule of the Code of Ordinances of West Carrollton, which includes the fees for various permits and services within the City; and

WHEREAS, with the adoption of Ordinance 3630 amending Chapter 117: Massage Services Establishments of the Code of Ordinances of the City of West Carrollton, it is now necessary to specify the Massage Services Establishment permit application fee as required by Section 117.03(H), the annual Massage Services Establishment permit renewal fee as required by Section 117.03(C), and the Massage Services Establishment permit transfer fee as required by Section 117.07(A).

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WEST CARROLLTON, COUNTY OF MONTGOMERY, STATE OF OHIO:

**SECTION I.** That by virtue of the authority vested in the City Council by the Charter for the City of West Carrollton, Chapter 37: General Fee Schedule of the Code of Ordinances of the City of West Carrollton shall be and hereby is amended as follows, for the purpose of specifying the Massage Services Establishment permit application fee as required by Section 117.03(H), the annual Massage Services Establishment permit renewal fee as required by Section 117.03(C), and the Massage Services Establishment permit transfer fee as required by Section 117.07(A):

## 37.38 Massage Services Establishment Permit Fees

The initial application for a Massage Services Establishment permit shall be accompanied by the payment of a fifty dollar (\$50) fee. (\$117.03(H)) A separate permit application fee is not required for each individual who performs massage services at a Massage Services Establishment which possesses a valid permit. (\$117.03(B)) Each subsequent annual renewal of a Massage Services Establishment permit shall be accompanied by the payment of a twenty-five dollar (\$25) fee. (\$117.03(C))

A permit to operate a Massage Services Establishment may be transferred by submitting a request in writing to the City of West Carrollton and payment of a twenty-five dollar (\$25) transfer fee. (§117.07(A))

**SECTION II.** That it is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised
