AN ORDINANCE LEVYING SPECIAL ASSESSMENTS FOR THE LIGHTING OF STREETS, LANES, AND OTHER PUBLIC WAYS IN THE CITY OF WEST CARROLLTON, OHIO WITH ELECTRIC LIGHTING.

WHEREAS, the Council of the City of West Carrollton passed Resolution 18-2020, which declared the necessity of this lighting assessment.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WEST CARROLLTON, OHIO, THAT:

<u>SECTION 1</u>: That the revised assessment of the cost and expense of the lighting of the streets, lanes, and other public ways in the City of West Carrollton, Ohio with electric light during the year 2019 amounting in the aggregate to \$159,970 as reported to this Council on 7/28/2020 be and the same is hereby adopted and confirmed and there is hereby levied and assessed upon all lots and lands lying and being within the corporate limits of the city and those amounts reported as aforesaid, which assessments are in proportion to the tax value thereof and are not in excess of any statutory limitation.

<u>SECTION 2</u>: That this Council hereby finds and determines that the revised assessments as now on file in the office of the said clerk and are in the same proportion of the estimated assessments as originally filed.

<u>SECTION 3</u>: That the assessment against each lot or parcel of land shall be payable in cash within thirty (30) days after passage of this ordinance or at the option of the owner in annual installments. All cash payments thereof remaining unpaid at the expiration of said thirty (30) days shall be certified by the Clerk of Council to the County Auditor as provided by the law to be placed by him on the tax duplicate and collected as other taxes are collected.

<u>SECTION 4</u>: That the Clerk of Council shall cause a notice of the passage of this ordinance to be published once in a newspaper of general circulation in this city and shall further retain on file in his office said revised assessment.

<u>SECTION 5</u>: The Clerk of Council is hereby directed to deliver a certified copy of this ordinance to the County Auditor after its passage.

<u>SECTION 6</u>: That this Ordinance shall take effect at the earliest possible date allowable by law.
