PURCHASE AGREEMENT WITH MVAH HOLDING LLC., A GEORGIA LIMITED

PURCHASE AGREEMENT WITH MVAH HOLDING LLC., A GEORGIA LIMITED LIABILITY COMPANY, OR IT SUCCESSORS FOR A 5.4 ACRE CITY OWNED PROPERTY (PARCEL NO.: K48-4-16-32) LOCATED AT 1450 ELM STREET, WEST CARROLLTON, OHIO 45449. THE SALES PRICE PER ACRE IS \$40,000 AND THE AGREED UPON SALES PRICE IS \$210,000.

WHEREAS, the City of West Carrollton, Ohio owns the 5.4 acre parcel located at 1450 Elm St., and acquired the property for the expressed purpose of community and economic development; and

WHEREAS, the city has listed the parcel as available for purchase; and

WHEREAS, the city has been in discussions with MVAH LLC, regarding their desire to develop the property into a Senior Housing development to provide a quality living environment for senior citizens; and

WHEREAS, the City and MVAH have mutually agreed to a purchase price of \$40,000 per acre; and

WHEREAS, during the option period of 180 days and two potential extensions of 90 days each, MVAH will work with the City to develop a Planned Unit Development that will define the development of the senior housing project and also conduct due diligence to include soil borings; and

NOW, THEREFORE, THE MUNICIPALITY OF WEST CARROLLTON, STATE OF OHIO, HERBY ORDAINS:

<u>SECTION 1</u>: That the City Manager and the Economic Development Director be and hereby are authorized to sell Option said property to MVAH LLC upon the following terms and conditions:

- 1. A sales price of \$40,000 per acre for a total sales price of \$210,000.
- 2. The City and MVAH work collaboratively to develop through zoning, a senior housing development project that provides a quality living environment for senior citizens to reside.
