AN ORDNANCE AUTHORIZING THE CITY MANAGER TO ENTER INTO A PURCHASE AGREEMENT WITH EROS INVESTMENTS LLC., AN OHIO LIMITED LIABILITY COMPANY FOR THE SALE OF 1201 SHERWOOD FOREST DRIVE, WEST CARROLLTON, OHIO.

WHEREAS, the City of West Carrollton owns the property located at 1201 Sherwood Forest Drive; and

WHEREAS, the City has no useful purpose for 1201 Sherwood Forest Drive; and

WHEREAS, the Municipality will benefit from the sale of the property to Eros Investments LLC as it will construct a new 1800 square foot two-story owner-occupied home on the lot for sale at market rates; and

WHEREAS, the City and Eros Investments LLC have mutually agreed upon a sale price of fifteen thousand (\$15,000) upon the completion of the home to the satisfaction of the city; and

WHEREAS, If Eros Investments LLC ultimately sells the property for a sale price of, or greater than, Two Hundred Fifty Thousand Dollars (\$250,000), Eros Investments will pay to the city an addition \$5,000.

NOW, THEREFORE, THE MUNICIPALITY OF WEST CARROLLTON, STATE OF **OHIO, HEREBY ORDAINS:**

SECTION 1: That the City Manager is hereby authorized to enter into a purchase agreement with Eros Investments LLC for the sale of the property located at 1201 Sherwood Forest Drive, West Carrollton, Ohio as well as all other contracts necessary to fulfill the terms of the purchase agreement.

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were taken in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 3: That this Ordinance shall take effect from and after the earliest period permitted by law.
