Ordinance No. 3726

AN ORDINANCE REVOKING ANY ORDINANCES IN CHAPTER 139: WEAPONS AND EXPLOSIVES OF THE CODE OF ORDINANCES OF WEST CARROLLTON REGARDING POSSESSION, USE, AND SALE OF FIREWORKS.

WHEREAS, the Ohio General Assembly has enacted House Bill 172 which amends Ohio fireworks laws; and

WHEREAS, Governor Mike Dewine signed House Bill 172 into law on November 8, 2021; and

WHEREAS, the amendment to Ohio fireworks laws impacts the possession, use, and sale of fireworks; and

WHEREAS, House Bill 172 goes into effect on July 1, 2022; and

**WHEREAS**, Council desires to repeal the appropriate Sections of 139.01 and 139.02 of the Code of Ordinances that are in conflict with House Bill 172.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WEST CARROLLTON, COUNTY OF MONTGOMERY, STATE OF OHIO:

**SECTION I:** Section 139.01 of the Code of Ordinances entitled *Possession, sale, and use of fireworks*, and section 139.02 of the Code of Ordinances entitled *Permit to use fireworks* be repealed. As a result of repealing these ordinances contained within chapter 139 of the Code of Ordinances, law enforcement will enforce the state code as it exists or as it may be amended concerning the possession, use, and sale of fireworks;

**SECTION II:** Section 139.03 of the Code of Ordinances entitled *Use of crossbows, bows and arrows prohibited* shall be renumbered Section 139.01

**SECTION III:** It is found and determined that all formal actions of Council concerning the passage of this ordinance were adopted in an open meeting of Council, and that all such deliberations of Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with legal requirements.

**SECTION IV:** That this ordinance is to be in compliance with the changes to the Ohio Revised Code which goes into effect on July 1, 2022, for the preservation of the public peace, health, welfare, and safety of the inhabitants of the City and shall take effect immediately upon passage.
