AN ORDINANCE AMENDING CHAPTER 36 COUNCIL RULES AND PROCEDURES OF THE CODIFIED ORDINANCES OF THE CITY OF WEST CARROLLTON.

WHEREAS, the City Council of the City of West Carrollton, Ohio desires to amend the Council Rules to correct a housekeeping issue.

NOW, THEREFORE, THE MUNICIPALITY OF WEST CARROLLTON, STATE OF OHIO, HEREBY ORDAINS:

**SECTION 1.** That the following Section shall be amended to read as follows, all other Sections of 36.02 shall remain in full force and effect and shall be incorporated herein by reference.

## Section 36.02 - Meetings

B. City Council will hold no less than one (1) meeting per month, unless an emergency is declared. Said meeting shall be held on the second or fourth Tuesday of the month. Said meeting shall be called to order at 6:30 p.m. in the Council Chambers of the City of West Carrollton or in any other public place within the corporate limits of the City of West Carrollton. The first Council meeting in January of each year shall be an organizational meeting of Council. At such meeting, the newly elected members of Council shall take the Oath of Office and the Council shall proceed to elect a Deputy Mayor and may transact any such other business as may come before it.

**SECTION 2.** That it is hereby found and determined that all formal actions of Council concerning and related to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any committees that resulted in formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121 of the Ohio Revised Code.

SECTION 3. That this ordinance shall take effect from and after the earliest period allowed by law.

	WHEREAS, the City Council of the City of West Carrollton, Ohio desires to amend the Council Rules to align with the language of the amendments to the City Charter that was voted in the affirmative in the general election on November 3, 2020.  NOW, THEREFORE, THE MUNICIPALITY OF WEST CARROLLTON, STATE OF OHIO, HEREBY ORDAINS THE FOLLOWING SECTIONS SHALL BE AMENDED TO READ AS FOLLOWS. ALL OTHER SECTIONS SHALL REMAIN AS WRITTEN.  Section 36.02 Meetings  B. City Council will hold no less than one (1) meeting per month, unless an emergency is declared. Said meeting shall be held on the second Tuesday of the month. Said meeting shall be called to order at 6:30 p.m. in the Council Chambers of the City of West Carrollton or in any other public place within the corporate limits of the City of West Carrollton. The first Council meeting in January of each year shall be an organizational meeting of Council. At such meeting, the newly elected members of Council shall take the Oath of Office and the Council shall proceed to elect a Deputy Mayor and may transact any such other business as may come before it.		
	Said meeting may be cancelled by the Mayor or four members of Council as a result of an emergency declared by City Council, State of Ohio Officials, County Officials or Federal Government Officials. An emergency would be any event that would endanger the lives of the citizens or create a risk to the health, safety and welfare of the citizens or property.		
	In the event there are conditions or a declared emergency that prevents City Council from meeting as one body in chambers, City Council may hold said meeting by teleconference/videoconferencing or other such technology that will meet the "in person" requirement under 121.22(C) as well as all other requirements of Ohio's Open Meeting Act.  C. Other special meetings may be called by the Mayor, or any four (4) members of Council, provided that notice is given to all members of Council, the Clerk of Council and the City Manager, at least 24 hours prior to such meetings, when practical, stating clearly the time, place and purpose of the meeting and provided the notice is given to persons and news media as provided in Subsections and hereof, Council may, by motion, at any meeting of the Council, establish another meeting date. Notice will be given as provided above.
