into an agreement on behalf of the City of West Carrollton with the West Carrollton Independent Employees Association (WCIEA), representing said employees in the West Carrollton, Ohio, Service Department and Parks and Recreation Department. A copy of the agreement is attached

hereto and made a part of this Ordinance by reference.

Section 3: Previous Ordinance: Ordinance No. 3661, a copy of which is attached

hereto, and any other ordinances in conflict herewith are hereby repealed.

Section 4: This ordinance is declared to be an emergency measure for the reason that

is it necessary to provide adequate compensation for certain employees in the Service Department and Parks and Recreation Department of the City of West Carrollton, and to approve certain terms of a contract entered into between the City of West Carrollton and the West Carrollton Independent Employees Association effective December 19, 2022 through December 14, 2025 and for these reasons it is necessary for the preservation of the public health, safety, and welfare of the citizens of West Carrollton;
