A RESOLUTION DECLARING THE NECESSITY FOR AN ADDITIONAL PROPERTY TAX FOR THE PURPOSE OF PROVIDING FUNDS FOR FIRE AND EMERGENCY MEDICAL SERVICES OPERATING EXPENSES FOR THE CITY OF WEST CARROLLTON, OHIO, AND PROVIDING FOR THE SUBMISSION OF SAID QUESTION FOR THE APPROVAL OF THE ELECTORS.

WHEREAS, the amount of taxes that may be raised by the levy of a property tax within the ten-mil limit prescribed by sections 5705.19, 5705.19(I), 5705.25, and 5705.26 of the Ohio Revised Code and the amounts presently imposed by the City of West Carrollton, will be insufficient to provide funds for operating expenses for the Fire Department of the City of West Carrollton, therefore making it necessary to increase the levy in excess of said limitations.

NOW THEREFORE, THE MUNICIPALITY OF THE CITY OF WEST CARROLLTON, STATE OF OHIO, HEREBY RESOLVES:

SECTION 1: That the Council of the City of West Carrollton declares that the amount of money that may be raised by the levy of an additional property tax within the limitations established by Section 5705.19, 5705.19(I), 5705.25, and 5705.26 of the Ohio Revised Code, together with all other funds available will be insufficient to provide an adequate amount to provide for maintaining motor vehicles, communications, and other equipment used directly in the operation of the City of West Carrollton Fire Department or the payment of salaries of regular full-time and part-time employees of the department or the payment of cost associated with other political subdivisions in order to obtain fire protection to be effective for five (5) years beginning January 1, 2021 and ending December 31, 2025.

SECTION 2: That a copy of this Resolution be certified to the Board of Elections of Montgomery County, Ohio, in order that said Board may make the necessary arrangements for submitting the question of such additional levy to the electors of the City of West Carrollton as required by Section 5705.19 of the Ohio Revised Code, at the primary election to be held in said City on the 17th day of March, 2020.

SECTION 3: That the ballot to be presented to said voters shall be in the following form, to wit:

PROPOSED TAX LEVY (ADDITIONAL)

CITY OF WEST CARROLLTON, OHIO

A majority affirmative vote is necessary for passage.

An additional tax for the benefit of the City of West Carrollton, Ohio, for the purpose of **PROVIDING FOR THE SALARIES OF REGULAR FULL-TIME AND PART-TIME FIRE AND EMERGENCY MEDICAL PERSONNEL, INCLUDING THE PAYMENT OF ANY EMPLOYER CONTRIBUTIONS REQUIRED UNDER THE OHIO REVISED CODE, OR PROVIDING AND MAINTAINING FIRE APPARATUS, MOTOR VEHICLES, COMMUNICATIONS, AND OTHER EQUIPMENT USED DIRECTLY IN THE OPERATION OF THE FIRE DEPARTMENT, OR THE PAYMENTS OF COSTS INCURRED BY THE CITY AS A RESULT OF CONTRACTS MADE WITH OTHER POLITICAL SUBDIVISIONS IN ORDER TO OBTAIN FIRE PROTECTION** at a rate not exceeding 3.9 mils for each one dollar of valuation, which amounts to \$ 0.39 for each one hundred dollars of valuation, for 5 years, commencing in 2020, first due in calendar year 2021.
