A RESOLUTION AUTHORIZING THE SUBMITTAL OF A COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM APPLICATION FOR PHASE 2 OF THE IMPROVEMENTS TO THE INTERSTATE 75 UNDERPASS AT ALEX-BELL ROAD, AND AUTHORIZING THE CITY MANAGER TO REPRESENT THE CITY IN FULFILLING PROGRAM REQUIREMENTS.

WHEREAS, federal criteria for the Community Development Block Grant (CDBG) program allow expenditures for one of three National Objectives: principally benefiting low to moderate income persons (at least 51 percent); eliminating and/or preventing slums and blight; and correcting emergency situations; and

WHEREAS, an eligible activity for the use of Community Development Block Grant (CDBG) funds is the construction, reconstruction or installation of infrastructure improvements; and

WHEREAS, the City of West Carrolton desires to submit an application seeking grant funds from the Community Development Block Grant (CDBG) program administered by Montgomery County for improvements to the Interstate 75 underpass at Alex-Bell Road, to supplement CDBG funds awarded in 2022 for phase 1 of this project; and

WHEREAS, the City of West Carrollton has the authority to apply for and to administer the amounts received from this program, and this project meets all eligibility requirements for said funding; and

WHEREAS, the City Council of the City of West Carrollton must direct and authorize the City Manager to act in connection with the application and to provide such additional information as may be required.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WEST CARROLLTON, MONTGOMERY COUNTY, OHIO:

<u>Section I.</u> That the City Manager be herewith authorized to act, and be designated as the official representative of the City of West Carrollton, in conjunction with all aspects of the preparation, filing, provision of information, and submittal of documentation necessary for participation in the Federal CDBG application and funding process, administered by Montgomery County, Ohio, all such activities being necessary to secure funding for improvements to the Interstate 75 underpass at Alex-Bell Road.

<u>Section II</u>. That the West Carrollton City Council hereby understands and agrees that participation in the Program will require compliance with program guidelines and assurances.
