CHECKLIST OF REQUIRED INFORMATION TO BE ATTACHED TO THE APPLICATION

- Written permission of the property owner(s) consenting to the Mobile Food Vendor operation on any and all properties on which the unit will operate, if applicable.
- A site plan showing any and all properties on which the unit will operate for sales purposes, with the proposed location and dimensions of the Mobile Food Vendor unit relative to buildings, parking and loading areas, streets and driveway approaches, refuse containers, and any other site information the City may require.
- Color photographs of all sides of the Mobile Food Vendor unit and any signage to be used in operation of the business.
- A valid copy of all licenses or permits required by the County of Montgomery, the State of Ohio, and any subsidiary enforcement divisions thereof, including but not limited to the Public Health - Dayton & Montgomery County and the Bureau of Motor Vehicles.
- Proof of registration with the City's income tax division if operating within the City for more than twenty (20) days in a calendar year.
- A signed statement that the vendor will hold harmless the City and its officers and employees, and shall indemnify the City, its officers and employees for any claims for damage to property or injury to persons which may be occasioned by any activity carried on under the terms of the Mobile Food Vendor License, as further described in Zoning Code Section 154.161.11 (B)(2)(ix).
