# Wastewater Treatment Plant Improvement Discussion

Service Director Norton provided a presentation to Council on proposed upgrades to the Wastewater Treatment Plant. He explained that the Master Plan conducted in 2023 identified several components in the plant to be past their useful life and/or maintenance intensive. He advised that they intended to bring a resolution forward on the January 23, 2024 meeting agenda for authorization to apply for a loan through Ohio EPA and Ohio Water Development Authority (OWDA) for design services.

Mr. Tilton asked if the capacity of the plant would be increased as a result of the improvements. Mr. Norton advised that the improvements would not increase capacity. Mrs. Zennie asked if we will discuss how we will pay for these improvements. Mr. Norton responded yes, noting that the sewer fund was healthy.

Mr. Tilton asked about the loan structure and rate. Mr. Norton explained that the design engineering phase was a 5 year, 0% interest loan, noting that the City could also choose to roll this loan into the future construction loan. Ms. Holloway advised that proceeding with the design engineering phase did not obligate Council to proceed with the upgrades to the plant.
