# Ohio Building Code Revised in 2024

### **Building Codes**

Ohio building code was revised March 1, 2024. There are significant changes to the commercial building code and minor changes to the residential code. Also, there are significant changes to the electrical code that apply to both commercial and residential projects.

# **Emergency** Repair Funding for Homeowners

# Fire Hydrant **Testing**

On Monday, April 1st, no foolin', the Fire Department will begin its yearly test of fire hydrants in the city. Testing will take place Monday through Friday

between 9 am - 4 pm. Every year,

the Fire Department marks the top of each hydrant with a different paint color to distinguish that the hydrant has been tested. This year's color will be GREEN.

Hydrants are flushed to make sure adequate water flow and pressure are available in the event of a fire. During testing, residents may notice discolored water coming from their faucets or washing machines, and we suggest running the cold water is clear to help avoid potential fabric stains.



# **FLOOD SAFETY TIPS**

Keep all brush and debris out of streams and ditches: this helps flood water to flow freely.

Store valuables and insurance papers in a waterproof container.

Call (937) 859-5783 to find out if your property is in a Flood Risk Zone.

Get a building permit before building in a floodplain.

If the road is underwater, turn around, don't drown. Ask your insurance agent if you are covered for flood damage.



# PREPARING FOR THE UPCOMING ECLIPSE

On Monday, April 8, 2024, people within Montgomery County as well as the surrounding Miami Valley will experience a total solar eclipse. Totality (darkness) will last 2 minutes and 42 seconds. The partial eclipse will begin at 1:53 pm, with totality arriving at 3:09 pm. It's expected that this event will bring large numbers of individuals into our area. A total solar eclipse is a rare and spectacular event. The last total solar eclipse visible in Ohio was in 1806. The next total solar eclipse in Ohio will be in the year 2099.



# WHAT IS THE CONCERN?

- Large crowds are expected to show up for a once-in-a-lifetime event.
- A prior eclipse in the USA (2017) had more than 5 million people view the event.
- Expect traffic jams that could last up to 13 hours after the eclipse.
- Rural roads may see increased traffic with drivers who are unfamiliar with local road conditions and may travel at a high rate of speed. Be mindful of children and pets.
- There is a possibility for cell phone & Wi-Fi to be significantly impacted based on the large number of viewers.

# **EXPECTATIONS/PLANNING PREPARATION**





Travel with water, medications, snacks, and other needed supplies should you encounter an extended delay on the roadways.



Begin the day with a fully charged mobile phone; carry extra power devices.



Fill up on gas at least the day before the eclipse.

- If viewing the eclipse, use eclipse glasses that meet ISO 12312- 2 standards.
- Expect employees to have long delays driving to and from work, day of the event.
- Maintain a small amount of cash on your person, in case credit card services go down.
- Check with your kids' school on their plans for the day (early off, delayed pick-up).

# West Carrollton City Schools – Update!

The community passed a Building Bond Issue in November 2019 to allow the construction of four new buildings. Passage of the Building Bond Issue locked in the commitment from the Ohio Facilities Construction Commission to pay for 81% of the co-funded cost of construction with the community portion being 19% of the co-funded cost.

A two-phase construction plan began immediately after the Building Bond Issue was passed.

#### **PHASE I**

- A new Early Childhood Center for preschool through first grade
- An Intermediate School for grades five and six

Both Phase I buildings opened for the first day of school of the 2022-23 school year on time and on budget!

#### **PHASE II**

Groundbreaking for Phase II construction was in October 2023 and was attended by community members, state, county, and city officials, members of the Bond Committee, school officials, and students.

- A new Elementary School for grades two through four (architect's rendering)
- A new Middle School/High School campus for grades seven through twelve (architect's rendering)

The new Elementary School will be built on the same property as the new Early Childhood Center and the Middle School/High School Campus will be built on the same property as the current High School.

West Carrollton Elementary is slated to open at the beginning of the 2025-2026 school year and West Carrollton Middle/High School Campus at the beginning of the 2026-27 school year.

Current elementary schools, the Middle School, and High School will hold Farewell Tours before the opening of new buildings. Those dates have not yet been scheduled.

Unregulated contaminants are those for which EPA has not established drinking water standards. The purpose of unregulated contaminant monitoring is to assist EPA in determining the occurrence of unregulated contaminants in drinking water and whether future regulation is warranted. In 2023 the City of West Carrollton participated in the fifth round of the Unregulated Contaminant Monitoring Rule (UCMR 5.) For a copy of the results please call the Utility Supervisor at (937) 847-6070. \*NOTE: None of the Unregulated Contaminants of the UCMR 5 were detected in the City of West Carrollton's water.

#### The City of West Carrollton 2023 Water Quality Report

The **USEPA** requires all community water systems to annually provide to their customers the following water quality report. The City of West Carrollton is proud of the quality drinking water it provides. This annual water quality report shows the source of our water, lists the results of our tests, and contains much important information about water and health. The West Carrollton Water Department will notify you if there is any reason for concern about our water. We are happy to show you how we have surpassed water-quality standards.

#### **OVERVIEW:**

In 1988 a new water plant was constructed to provide a high-quality, reliable supply of water to the nearly 12,000 consumers served. In early 2005 a membrane filtration softening plant was put on line that significantly reduces the hardness level in the water. In 2023 the City of West Carrollton has an unconditioned license to operate our water system.

#### An Explanation of the Water-Quality Data Table:

The data presented in this report is from the most recent testing done in accordance with regulations by the West Carrollton Water Department. Terms used in the Water-Quality Table and in other parts of this are defined here.

#### **DEFINITIONS:**

Maximum Contaminant Level (MCL): The highest level of a contaminant that is allowed in drinking water. MCLs are set at close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Action Level (AL): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Residual Disinfectant Level Goal (MRDLG): The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Maximum Residual Disinfectant Level (MRDL): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfec-tant is necessary for control of microbial contaminants.

#### **WATER SOURCE:**

The source of West Carrollton's Drinking Water comes exclusively from groundwater through wells drilled into the aquifer that lies beneath West Carrollton. The aquifer extends the length of the Miami Valley. Residents are encouraged to report activity or spills that could cause contamination of the underground aquifer. Ohio EPA has fully endorsed the city's well head protection program which safeguards the city's water supply for future generations.

#### REQUIRED ADDITIONAL HEALTH INFORMATION:

In order to ensure that tap water is safe to drink, USEPA prescribes regulations which limit the amount of certain contaminants in water provided by public water. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health. Drinking water, including bottled water, may reasonably be expected to contain a least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

The source of drinking water (both tap water and bottled water) includes rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the sur-face of the land or through the ground, it dissolves naturally-occurring minerals and in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water

- (A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife. (B) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.
- (C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses.
- (D) Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum productions, and can also come from gas stations, urban stormwater runoff and septic systems. (E) Radioactive contaminants, which can be naturally-occuring or be the result of oil and gas production and mining activities.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of West Carrollton is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by fl ushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline at 1-800-426-4791 or at http://www.epa.gov/safewater/lead.

We encourage public interest in our community's decisions affecting drinking water. Ohio EPA completed a study of the City of West Carrollton's source of drinking water to determine its susceptibility. According to the study, the aquifer (water rich zone) that supplies water to the City of West Carrollton has a high susceptibility to contamination. This determination is based on the following:

lack of a protective layer of clay overlying the aquifer; shallow depth (less than 15 feet below ground surface) of the aquifer; and the presence of significant poten-tial contaminant sources in the protection area. The City of West Carrollton has developed and implemented a comprehensive wellhead protection plan to help prevent additional contamination from entering the aquifer and prevent the existing contamination from impacting the drinking water source. The protection plan contains an education component, source control strategies, a contingency and emergency response plan, and ground water monitoring strategies. More information about the source water assessment or what consumers can do to help protect the aquifer is available by calling (937) 847-6070.

The Consumer Confidence Report (CCR) reflects changes in the drinking water regulatory requirements during 2016. All water systems were required to comply with the Total Coliform Rule from 1989 to March 31, 2016, and begin compliance with a new rule, the Revised Total Coliform Rule on April 1, 2016. The new rule maintains the purpose to protect public health by ensuring the integrity of the drinking water distribution system and monitoring for the presence of total coliform bacteria, which includes E. coli bacteria. The U.S. EPA anticipates greater public health protection under the new rule, as it requires water systems that are vulnerable to microbial contamination to identify and fix problems. As a result, under the new rule there is no longer a maximum contaminant level violation for multiple coliform detections. Instead, the new rule requires water systems that exceed a specified frequency of total coliform occurrences to conduct an assessment to determine if any significant deficiencies exist. If found, these must be corrected by the Public Water System. How to read the Water Quality Data Table: EPA establishes the safe drinking water regulations that limit the amount of contaminants allowed in drinking water. The table shows the concentrations of detected substances in comparison to regulatory limits. Substances that were tested for, but not detected, are not included in this table.
