<u>Ordinance 3772</u> – An Ordinance To Approve Current Replacement Pages To The West Carrollton Codified Ordinances, And Declaring An Emergency.

Law Director Denlinger presented Ordinance 3772. She explained this is a necessary step in the codification process. This will allow for American Legal to update and publish all local ordinances online through July 11, 2023, and statutory updates through April 5, 2023. Mayor Barnhart asked if there were questions or comments for Ms. Denlinger or Ms. Holloway. There were no questions, but Mr. Dobson commented on the amount of work that goes into the process and thanked Mrs. Moore.

Mayor Barnhart introduced Resolution 17-2024.

<u>Resolution 17-2024</u> – A Resolution Authorizing The Submittal Of A Community Development Block Grant (CDBG) Program Application For The Construction Of Four City Gateway Signs, And Authorizing The City Manager To Represent The City In Fulfilling All Program Requirements.

City Manager Holloway presented Resolution 17-2024. She stated this resolution allows for staff to apply for Community Development Block Grant funds for FY 2024. She stated an application has been prepared for Montgomery County requesting \$82,560 in funding to construct four gateway signs. These are stone pillar signs in the same style as our current gateway signs. Ms. Holloway stated the signs would enhance our image and the visual appearance of our community. She further stated brand implementation was a 2023 City Council Top Ten Priority. Ms. Holloway turned the floor over to Planning & Community Development Director Gaines for further explanation.

Planning & Community Development Director Gaines gave a history of the stone pillar signs, and provided photos of the twelve remaining gateway signs that need replaced. Mr. Gaines stated if the grant is awarded staff would come back to Council to determine which signs to select for replacement. Mr. Gaines explained Montgomery County typically makes the grant awards in the fall, with the funding being available by the following spring. If the grant is successful, the signs would be constructed in the Spring/Summer of 2025. Mr. Gaines stated an estimate was received for planning purposes from the company who did the sign entering the Civic Center; however, if awarded the project would have to go through the formal bid process.

Mayor Barnhart asked if there were questions or comments for Ms. Holloway or Mr. Gaines. There were none.

Ordinance 3773 – An Ordinance To Make Appropriations For Current Expenses And Other Expenditures Of The City Of West Carrollton, State Of Ohio, During The Fiscal Year Ending December 31, 2024, Amending Ordinance 3771, And Repealing Any Ordinances In Conflict Herewith.

City Manager Holloway presented Ordinance 3773. She explained this supplemental appropriation addresses two areas, which include the funding of an Assistant City Manager and River District Infrastructure Improvements.

With the upcoming retirement of Part-Time Economic Development Director Micheal Lucking, Ms. Holloway would like to pursue hiring an Assistant City Manager. The Assistant City Manager pay scale was included in the 2024 Pay Ordinance, but it was not funded in the FY2024 budget. She proposed reallocating salary funds from the Economic Development Fund and from the Finance/Income Tax Fund to cover this position for this year. The total amount needed is \$78,000.

The River District is a multi-year development project that will continue to evolve. It has become necessary to create a "spine road" across the parcel at 1100 East Dixie Drive, which was not included in the engineering design of Phase 1 improvements. Ms. Holloway proposed a General Fund advance to the River District Fund to cover the initial design, and then it be repaid with future anticipated land sale proceeds. The estimate for the design/engineering of the "spine road" is \$160,000.

Mayor Barnhart asked if there were questions for Ms. Holloway. There were none. Mayor Barnhart stated this is the first reading of Ordinance 3773. It will be on the next agenda.

<u>Presentation from Thompson Hine / Plan of Finance Discussion for West Carrollton River District</u> and Whitewater Park – Michael Lucking and Arik Sherk (Thompson Hine)

She also addressed several upcoming needs for the River District Development, including the design of a spine road across 1100 E. Consultants Joe Tuss of JT Consulting and Arik Shirk from Thompson Hine then presented the plan of finance for the River District Development to City Council.
