Mayor Barnhart introduced Resolution 20-2024.

<u>Resolution 20-2024</u> – A Resolution Authorizing The City Manager to Enter Into a Lease Agreement with the Miami Conservancy District

City Manager Holloway presented Resolution 20-2024. She stated this resolution would authorize the city to enter into a lease agreement with the Miami Conservancy District for approximately 86 acres of land along and within the Great Miami River. She stated this lease agreement is a critical next step in the development of the Whitewater Park and River District.

Law Director Denlinger made a recommendation to reconsider tabling Resolution 20-2024 to the next meeting in July when all Councilmembers could be in attendance.

Mayor Barnhart introduced Resolution 21-2024.

Resolution 21-2024 – A Resolution Authorizing The City Manager To Apply For, Accept, And Enter Into A Water Supply Revolving Loan Account (WSRLA) Agreement On Behalf Of The City Of West Carrollton, Ohio For The Construction Of The Water Treatment Plant Upgrade Project; And Designating A Dedicated Repayment Source For The Loan; And To Advertise For Bids For The Construction Of The Water Treatment Plant Upgrade Project And To Expend A Sum In Excess Of \$75,000 Therefore.

City Manager Holloway presented Resolution 21-2024. She explained this resolution would authorize the city to apply, accept, and enter into a Water Supply Revolving Loan Account Agreement to upgrade the Water Treatment Plant. The necessary plant upgrades are estimated to cost approximately \$8,703,600. Debt for this loan, if awarded, would come from the Water Fund Account 602. The design of the Water Treatment Plant upgrade has been in the works since 2023.

Mayor Barnhart asked if there were questions or comments. Mr. Dobson commented the \$8,000,000 is not necessarily the final cost because that is at sixty percent of the plan. He also stated he wanted the community to know the city will do their best not to raise water rates, but that cannot be guaranteed because of this project being such a large expenditure.
