Ordinance No. 3788

Passed: December 10, 2024

AN ORDINANCE TO APPROVE CURRENT REPLACEMENT PAGES TO THE WEST CARROLLTON CODIFIED ORDINANCES.

WHEREAS, certain provisions within the West Carrollton Code of Ordinances should be amended to conform with current State law as required by the Ohio Constitution; and

WHEREAS, various ordinances of a general and permanent nature have been passed on or before April 30, 2024 by City Council as well as updated legislation by the State of Ohio through February 28, 2024 which should be included in the Codified Ordinances; and

WHEREAS, the City has heretofore entered into a contract with American Legal Publishing to prepare and publish such revision which is before Council;

NOW, THEREFORE, THE MUNICIPALITY OF WEST CARROLLTON, OHIO, HEREBY ORDAINS:

Section 1: That the ordinances of the City of West Carrollton, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the 2024 Replacement Pages to the Codified Ordinances are hereby approved and adopted.

Section 2: That the following sections and chapters are hereby added, amended or repealed and repealing any Ordinance in conflict herein as respectively indicated in order to comply with current State law.

Section 4: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 5: That this ordinance shall take effect from and after the earliest period allowed by law.
