POSITION TITLE: FIREFIGHTER/EMT/PARAMEDIC

GENERAL NATURE OF WORK: Under the direction of the Fire Captain, you will perform a diverse range of functions associated with fire suppression, EMS, fire prevention, station, and equipment maintenance activities for West Carrollton. Your work will include responding to emergency firefighting and medical situations, such as vehicle accidents, swift water rescues, and other medical and rescue emergencies.

You will work in intense, life-threatening conditions, demonstrating your bravery and commitment. Essential and marginal functions require maintaining the physical condition necessary for running, walking, crawling, climbing, stooping, and heavy lifting while wearing heavy protective equipment and working in inclement weather conditions.

EQUIPMENT & JOB LOCATION: This position requires thorough knowledge of fire/EMS tools and equipment, including computers, communication equipment, fire/EMS vehicles, and general office equipment. The job site includes a diverse range of areas both inside and outside the City of West Carrollton, reflecting the varied nature of the role.

ESSENTIAL FUNCTIONS – EXAMPLES OF DUTIES:

Any one position may not include all of the listed duties, and the examples listed do not include all duties that may be found in all positions in this class.

- Responds to fire, EMS, rescue, and public service alarms.
- Operates emergency vehicles, including but not limited to staff vehicles, pumpers, aerial ladders, medic units, and rescue boats, safely and legally under all weather conditions and in response to emergency situations.
- Safely and effectively operates equipment such as fire extinguishers, pry bars, hooks, ropes, aerial ladders, power tools, self-contained breathing apparatus, specialty equipment, etc.
- Lay and connect hose, hold nozzles and direct water streams, raise and climb ladders, ventilate burning structures, enter buildings to evacuate occupants, and/or extinguish the fire.
- Performs salvage operations such as covering exposed furniture and removing excess water and debris.
- Administers life support to injured persons, including techniques to restore cardio-pulmonary functions.
- Performs public education presentations on fire safety and emergency care throughout the community.
- Determines the need for and performs general maintenance work in the upkeep of fire
 department property, such as maintaining and testing fire hoses, cleaning and polishing
 apparatus, making minor repairs to various pieces of equipment, and cleaning and maintaining
 buildings and grounds.
- Testing and inspection of fire hydrants.
- Participates in formal classroom and on-the-job training in modern firefighting methods and techniques, fire prevention procedures, emergency victim care, etc.

- Thorough knowledge of using and operating various fire and emergency medical equipment.
- Considerable knowledge of the occupational hazards and corresponding safety practices necessary to safely perform work duties.
- Demonstrates the ability to differentiate between safe and unsafe conditions.
- General knowledge of the operation, care, and maintenance of tools and equipment utilized in performing assigned duties.
- Ability to learn the city's geography, water system, and major target hazards.
- Ability to perform both routine and specialized firefighting and emergency medical tasks with skill and competence.
