A RESOLUTION BY THE COUNCIL OF THE CITY OF WEST CARROLLTON, OHIO REQUESTING THE AUDITOR OF MONTGOMERY COUNTY TO CERTIFY THE TOTAL CURRENT TAX VALUATION OF THE CITY OF WEST CARROLLTON, ENTIRELY LOCATED IN MONTGOMERY COUNTY, AND THE DOLLAR AMOUNT OF REVENUE THAT WOULD BE GENERATED BY A 3.9 MILL RENEWAL LEVY PROVIDING FOR THE SALARIES OF REGULAR FULL-TIME AND PART-TIME FIRE AND EMERGENCY MEDICAL PERSONNEL, INCLUDING THE PAYMENT OF ANY EMPLOYER CONTRIBUTIONS REQUIRED UNDER THE OHIO REVISED CODE, OR PROVIDING AND MAINTAINING FIRE APPARATUS, MOTOR VEHICLES, COMMUNICATIONS, AND OTHER EQUIPMENT USED DIRECTLY IN THE OPERATION OF THE FIRE DEPARTMENT, OR THE PAYMENTS OF COSTS INCURRED BY THE CITY AS A RESULT OF CONTRACTS MADE WITH OTHER POLITICAL SUBDIVISIONS IN ORDER TO OBTAIN FIRE PROTECTION AS AUTHORIZED BY SECTION 5705.19(I), OF THE OHIO REVISED CODE.

WHEREAS, the Council of the City of West Carrollton, Ohio entirely located in Montgomery County, hereby declares the necessity of a renewal tax levy in excess of the ten-mill limitation in the amount of 3.9 mills in accordance with O.R.C. 5705.03(B)(1); and

WHEREAS, O.R.C. 5705.03 (B)(1) requires the City to request the County Auditor to certify a total current tax valuation of the City of West Carrollton and the dollar amount of revenue that would be generated by the specified number of mills.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WEST CARROLLTON, MONTGOMERY COUNTY, OHIO:

Section 1: The Council of the City of West Carrollton, Ohio entirely located in Montgomery County, in accordance with O.R.C. 5705.03 (B), requests the Montgomery County Auditor to certify the current total tax valuation of the City of West Carrollton and the dollar amount of revenue that would be generated by a 3.9 mill renewal levy for a 5-year period.

Section 2: It is necessary that the additional tax be levied in excess of the ten-mil limitation for the purpose of Providing for the Salaries of Regular Full-Time and Part-Time Fire and Emergency Medical Personnel, Including the Payment of Any Employer Contributions Required Under the Ohio Revised Code, or Providing and Maintaining Fire Apparatus, Motor Vehicles, Communications, and Other Equipment Used Directly in the Operation of the Fire Department, or the Payments of Costs Incurred by the City as a Result of Contracts Made with Other Political Subdivisions in Order to Obtain Fire Protection as Authorized by Section 5705.19(I), of the Ohio Revised Code.

<u>Section 3</u>: The question of passage of said renewal tax levy shall be submitted to the electors of the City of West Carrollton at an election to be held on May 6, 2025. If a majority of the voters voting on this renewal levy vote in favor thereof, this levy shall be first placed on the tax list and duplicate for the tax year of 2025, for collection in calendar year 2026.

<u>Section 4</u>: Pursuant to Section 5705.03 of the Ohio Revised Code, the County Auditor is hereby requested to certify to the City of West Carrollton the total current tax valuation of the City and the dollar amount of revenue that would be generated by the number of mills specified in Section
