Mayor Barnhart introduced Resolution 3-2025.

Resolution 3-2025 - A Resolution By The Council Of The City Of West Carrollton, Ohio Requesting The Auditor Of Montgomery County To Certify The Total Current Tax Valuation Of The City Of West Carrollton, Entirely Located In Montgomery County, And The Dollar Amount Of Revenue That Would Be Generated By A 3.9 Mill Renewal Levy Providing For The Salaries Of Regular Full-Time And Part-Time Fire And Emergency Medical Personnel, Including The Payment Of Any Employer Contributions Required Under The Ohio Revised Code, Or Providing And Maintaining Fire Apparatus, Motor Vehicles, Communications, And Other Equipment Used Directly In The Operation Of The Fire Department, Or The Payments Of Costs Incurred By The City As A Result Of Contracts Made With Other Political Subdivisions In Order To Obtain Fire Protection As Authorized By Section 5705.19(I), Of The Ohio Revised Code.

City Manager Holloway presented Resolution 3-2025. If approved, this resolution would request the Montgomery County Auditor to certify the City of West Carrollton's total current tax valuation and the revenue generated by a 3.9 mill renewal levy. She further explained voters approved a 3.9 mill five-year fire levy in March of 2020. If this levy does not get renewed it will expire at the end of 2025. A renewed levy would ensure continued support in funding fire department personnel, equipment and maintenance. This resolution is the first step in a two-part legislative process to place this on the ballot for voter approval May 6, 2025.

Mayor Barnhart asked Council if there were any questions or comments. There were none.
