Resolution No. 15-2025

Passed: Lubrvary 25, 2025

A RESOLUTION DECLARING THE NECESSITY THAT CERTAIN SIDEWALKS, DRIVE APPROACHES, CURBS, AND GUTTERS SHALL BE CONSTRUCTED FOR THE 2025 PROGRAM.

WHEREAS, it is the determination of the City Council that notice of the passage of this Resolution should be served upon the affected property owners at the earliest possible moment so that the construction or repair herein indicated may be accomplished during the present construction season.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WEST CARROLLTON, STATE OHIO:

Section 1: The City Council declares the necessity to undertake a program for the construction or repair of sidewalks, drive approaches, and curbs and gutters which may have become damaged or defective located within the City of West Carrollton as set forth in "Exhibit A", which is attached hereto and made a part hereof. Said construction or repair shall be in accordance with the plans, specifications, and estimates of the proposed improvements which shall be on file in the office of the Clerk of Council by February 26, 2025, and open to inspection by any and all interested persons. These plans, specifications and estimates are hereby specifically approved by the City Council.

Section 2: That the owners of all lots and land bounding and abutting on the sidewalks, drive approaches, and curbs and gutters to be constructed or repaired shall construct or repair in accordance with the plans and specifications of the proposed improvements to be on file by February 26, 2025, the portions of such sidewalks, drive approaches, and curbs and gutters abutting on their respective properties by June 2, 2025 (with excavation permit secured by April 30, 2025); and if such construction or repair is not completed by June 2, 2025, then this City Council shall have the same done and the entire cost thereof shall be assessed upon the property of each defaulting owner and lien thereon, to be collected in the manner provided by law, in up to ten (10) annual installments with penalty and interest as provided by law.

<u>Section 3</u>: That the Clerk of Council is hereby directed to cause a written notice of the passage of this Resolution to be served as required by law.

<u>Section 4</u>: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

LEGAL NOTICE TO CONSTRUCT OR REPAIR SIDEWALK, DRIVE APPROACH, CURB. AND GUTTER

You are hereby notified that you are required to construct or repair the sidewalk, drive approach, curb and gutter abutting your premises in accordance with the attached plans at:

«FULL_ADDRESS»

A permit to do the work must be secured from the Service Department by the property owner's contractor or by the property owner if the owner elects to do the work themselves. The permit fee is \$34.00 (subject to annual adjustment). The permit is used to help verify that the WORK and FINAL INSPECTION is complete, so that the work is not released to the City Contractor and, therefore, billed to you. A green APPROVAL tag will be left at the property after the FINAL INSPECTION has been made and work is approved.

All contractors must post a \$5,000 excavation bond prior to obtaining a permit. Homeowners electing to do their own curb repairs must post an excavation bond equal to the cost of the curb repairs.

If said sidewalk, drive approach, curb and gutter are not so constructed or repaired in accordance with such plans and specifications, nor a permit secured prior to **April 30, 2025**, the City will perform the necessary work as a part of the 2025 Curb and Sidewalk Repair Program. Attached is an **ESTIMATED** cost for the work. The **ACTUAL PRICE** will be based on bid prices determined by the City's public bid opening. Once the work has been completed, you will receive an invoice that will include the final cost of the improvements and payment instructions. The total cost of the improvements may be paid directly to the City or assessed to the property's tax duplicate. Any amount certified to the County for assessment will include additional interest and fees. Interest rates will be determined after the public bid opening. A 5% County administrative fee will be added to all certified amounts. We anticipate that invoices will be mailed in October 2025.
