Title: Construction Water Permit Fees

- (A) Any person, firm, or corporation constructing a building or buildings for which a water tap into the municipal system is required shall secure from the city a permit for construction water, the fee for which shall be based upon the total estimated construction cost of the building or buildings according to the following schedule:

CONSTRUCTION COST

PERMIT FEE

Up to and including \$80,000

The current minimum charge in effect for a 5/8" to 3/4" meter. (See §50.02)

\$80,001 and above

The current minimum charge as above plus \$0.29 per \$1,000 of cost or fraction thereof in excess of \$80,000

This permit shall be obtained and paid for at the time the building permit is secured. This provision shall not apply to the construction of garages, storage sheds or additions to existing buildings, where water under meter control is already being billed.

The use of construction water includes the right to use water for construction purposes, sanitation purposes, and for the testing of water and sewer lines during the construction phase, but in no event shall the right to use the water extend beyond the time of the final inspection, or the cessation of normal building activities when the construction is complete or purposely held incomplete, whichever is earliest.

- (B) Any person, firm or corporation requesting temporary water usage for an existing building construction or maintenance project shall submit a fire hydrant meter deposit of \$1,117.00 (refundable). Water usage shall be the current minimum charge in effect for a 5/8" to 3/4" meter, plus the current additional charge per 1,000 gallons used over the minimum 10,000 gallons.

The Zoning Code requires any entity seeking to operate a hookah bar in the city to apply for and receive a license issued by the Chief of Police and to renew it annually.

All Hookah Bars required to be licensed under Section 154.16.12 of the Zoning Code shall pay a non-refundable annual license fee of one hundred forty-five (\$145) upon approval of the license or license renewal by the Chief of Police. This license fee shall be in addition to other fees which may be required in order to operate the Hookah Bar.

(A) The following fees for applications presented to the City are hereby established:

- (1) Preliminary Subdivision Plan or Minor Change to PUD Plan: \$134 per plan. In addition, the applicant shall pay the City a plan review fee for the cost of engineering review of the preliminary subdivision plan. This plan review fee shall be the actual cost which the City paid the engineering consultant(s) to review the plan and shall be paid at the time the preliminary subdivision plan has been approved by the City.
- (2) Preliminary PUD Plan: \$205 per plan. In addition, the applicant shall pay the City a plan review fee for the cost of engineering review of the preliminary PUD plan. This plan review fee shall be the actual cost which the City paid the engineering consultant(s) to review the plan and shall be paid at the time the preliminary PUD plan has been approved by the City.
- (3) Record plan, final PUD plan, major change to PUD plan, site plan, and public improvement construction inspection:
 - (a) \$205 per plan, plus 4% of the performance bond if required by law, adjusted to the actual inspection cost if less than 4%. However, if the public improvements are constructed as part of any development not requiring a performance bond, a fee of 4% of the approved estimated cost of construction shall be payable before city approval of the construction drawings. This fee shall be adjusted to the actual inspection cost if less than 4%.
 - (b) The applicant shall also pay the City a plan review fee for the cost of engineering and/or landscaping review. This plan review fee shall be the actual cost which the City paid engineering and/or landscaping consultants to review the plans and shall be paid at the time the plan has been approved by the City.
- (4) City Center District Site Development Plan:

- (a) New construction, additions greater than 50 percent of the area of the principal structure, and site improvements: \$205 per site development plan, plus 4% of the performance bond if required by law, adjusted to the actual inspection cost if less than 4%. However, if the public improvements are constructed as part of any development not requiring a performance bond, a fee of 4% of the approved estimated cost of construction shall be payable before City approval of the construction drawings. This fee shall be adjusted to the actual inspection cost if less than 4%.
- (b) Additions less than 50 percent of the area of the principal structure, signage and landscaping/screening: \$135 per site development plan and 4% of the performance bond if required by law, adjusted to the actual inspection cost if less than 4%. However, if the public improvements are constructed as part of any development not requiring a performance bond, a fee of 4% of the approved estimated cost of construction shall be payable before city approval of the construction drawings. This fee shall be adjusted to the actual inspection cost if less than 4%.
- (c) The applicant shall also pay the city a plan review fee for the cost of engineering and/or landscaping review of site development plans. This plan review fee shall be the actual cost which the city paid engineering and/or landscaping consultants to review the plans and shall be paid at the time the plan has been approved by the city.
- (5) Approval without a plat (lot splits, five or less lots): \$34 for the first lot and \$11 for each lot thereafter, not to exceed a maximum fee of \$102.
- (6) Performance bond and subdivider contract preparation: \$33 for each performance bond and subdivider contract combination.
- (7) Zoning map or text amendment: \$199. In addition, the applicant shall pay the city a plan review fee for the cost of engineering review of the zoning map amendment. This plan review fee shall be the actual cost which the city paid the engineering consultants to review the plan and shall be paid at the time the application has been approved by the city.
- (8) Conditional use permit: \$131. In addition, the applicant shall pay the city a plan review fee for the cost of engineering and/or landscaping review of the conditional use permit application, if such review is determined necessary. This plan review fee shall be the actual cost which the city paid the engineering and/or landscaping consultants to review the plan and shall be paid at the time the application has been approved by the city.

- (9) Variance application: \$99. In addition, the applicant shall pay the city a plan review fee for the cost of engineering and/or landscaping review of the variance application, if such review is determined necessary. This plan review fee shall be the actual cost which the city paid the engineering and/or landscaping consultants to review the plan and shall be paid at the time the application has been approved by the city.
- (10) Appeal to Board of Zoning Appeals: \$99. In addition, the applicant shall pay the city a plan review fee for the cost of engineering and/or landscaping review of the appeal, if such review is determined necessary. This plan review fee shall be the actual cost which the city paid the engineering and/or landscaping consultants to review the plan and shall be paid at the time the application has been approved by the city.
- (11) Special Sign Package: \$99. In addition, the applicant shall pay the city a plan review fee for the cost of engineering and/or landscaping review of the appeal, if such review is determined necessary. This plan review fee shall be the actual cost which the city paid the engineering and/or landscaping consultants to review the plan and shall be paid at the time the application has been approved by the city. This fee shall be in addition to any required sign permit fees.
- (B) The fees as established shall be used by the city to defray the costs of processing such applications and shall, unless otherwise indicated, be paid by the applicant to the city at the time of filing the application with the city.

Any fee charged by a municipal corporation under Section 4939.031 of the Revised Code for granting or processing an application for consent shall not exceed a one-time fee of two hundred fifty dollars (\$250) per small cell facility. Beginning on the effective date of this Section, a municipal corporation may adjust this fee ten percent (10%) every five years, rounded to the nearest five dollars (\$5). During each five-year period, the adjustment may be applied incrementally or as a single adjustment.

§ 99.09 RECOVERY OF COSTS.

(A) Application processing fee. For processing an application for consent, the city may charge a fee for each small cell facility and wireless support structure requested as prescribed under R.C. § 4939.0316 and as listed in Chapter 37: General Fee Schedule.

(B) Annual collocation fee. For reimbursement for operator's attachment of small cell facilities to wireless support structures owned or operated by the city and located in the right-of-way, the city may charge an annual fee as prescribed in R.C. § 4939.022 and as listed in Chapter 37: General Fee Schedule.

(C) Tax liabilities and assessments not applicable. Placement of small cell facilities in the right-of-way or attachment of small cell facilities to a wireless support structure and any fees associated therewith shall not subject the city to any state or local tax liabilities or assessments.
