A RESOLUTION AUTHORIZING THE SUBMITTAL OF AN ACCELERATED COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM APPLICATION TO INSTALL LED LIGHTING AT THE I-75/ALEX-BELL ROAD UNDERPASS, AND AUTHORIZING THE CITY MANAGER TO REPRESENT THE CITY IN FULFILLING ALL PROGRAM REQUIREMENTS.

WHEREAS, in addition to the regular FY2025 Community Development Block Grant (CDBG) funding cycle, Montgomery County is also conducting a mini-funding review process to quickly allocate remaining CDBG funds from previous program years to shovel-ready projects that have not yet started but can be completed by late spring or summer 2025; and

WHEREAS, these projects must still meet one of three National Objectives: principally benefiting low to moderate income persons (at least 51 percent); eliminating and/or preventing slums and blight; and correcting emergency situations; and

WHEREAS, an eligible activity for the use of Community Development Block Grant (CDBG) funds is the construction, reconstruction or installation of infrastructure improvements; and

WHEREAS, the City of West Carrolton desires to submit an application seeking grant funds from the accelerated Community Development Block Grant (CDBG) program administered by Montgomery County for improvements to the lighting on the underpass at Interstate 75 and Alex-Bell Road; and

**WHEREAS**, the City of West Carrollton has the authority to apply for and to administer the amounts received from this program, and this project meets all eligibility requirements for said funding; and

**WHEREAS**, the City Council of the City of West Carrollton must direct and authorize the City Manager to act in connection with the application and to provide such additional information as may be required.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WEST CARROLLTON, OHIO, THAT:

**Section I.** The City Manager, or her designee, be herewith authorized to act, and designated as the official representative of the City of West Carrollton, in conjunction with all aspects of the preparation, filing, provision of information, and submittal of documentation necessary for participation in the Federal CDBG application and funding process, administered by Montgomery County, Ohio, all such activities being necessary to secure funding for new lighting for the underpass at Interstate 75 and Alex-Bell Road.

**Section II.** The West Carrollton City Council hereby understands and agrees that participation in the Program will require compliance with program guidelines and assurances.

**Section III.** The Clerk of Council is hereby directed to cause a written notice of the passage of this Resolution to be served as required by law.
