AN ORDINANCE VACATING 0.841 ACRES OF UNNEEDED PUBLIC RIGHT-OF-WAY LOCATED ADJACENT TO 1000 E. DIXIE DRIVE.

WHEREAS, a petition was filed by the City of West Carrollton requesting the vacation of 0.841 acres of unneeded public right-of-way located adjacent to 1000 E. Dixie Drive; and

WHEREAS, the petition request was reviewed by the Planning Commission at a public hearing held on June 26, 2025, at which time all people who wished to testify gave their comments, and the Planning Commission unanimously recommends approval of the proposed petition; and

WHEREAS, a Notice of Public Hearing before City Council regarding this application was mailed on July 2, 2025 to all abutting property owners within 200 feet; and

WHEREAS, a sign regarding this matter was placed in a conspicuous location on the property; and

WHEREAS, the application and Notice of Public Hearing were posted on the City's website; and

WHEREAS, the petition request was reviewed by the City Council at a public hearing held on July 8, 2025, at which time all people who wished to testify gave their comments; and

WHEREAS, this petition has been filed and reviewed pursuant to and in accordance with Chapter 723 of the Ohio Revised Code.

NOW, THEREFORE, THE MUNICIPALITY OF WEST CARROLLTON, OHIO, HEREBY ORDAINS:

<u>Section 1</u>: That the City Council finds that there is good cause for vacating 0.841 acres of unneeded public right-of-way located adjacent to 1000 E. Dixie Drive, and such vacation will not be detrimental to the public interest.

<u>Section 2</u>: That the 0.841 acres of unneeded public right-of-way located adjacent to 1000 E. Dixie Drive, as reflected in Exhibit A and Exhibit B attached hereto, be and hereby is vacated.

<u>Section 2:</u> That the Clerk of Council is hereby directed to certify a copy of this ordinance to the Recorder and Auditor of Montgomery County, Ohio, so that this vacation provided herein may become part of the official public records of said county.

<u>Section 3</u>: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including but not limited to Section 121.22 of the Ohio Revised Code.

EXHIBIT A LEGAL DESCRIPTION R/W VACATION

thence, North 83°38'57" West, 212.57 feet, to a point on the west line of said 2.58-acre tract;
