City Manager Holloway presented Ordinance 3811. She stated Council received a memo from Finance Director Duffy regarding this supplemental appropriation, and requested Council consider it as an emergency.

Ordinance 3812 – An Ordinance To Authorize The Establishment Of The "Whitewater Park Capital Fund (419)" For The Purpose Of Receiving And Expending Funds For The Development Of The Whitewater Park For The City Of West Carrollton, Ohio, And Declaring An Emergency.

City Manager Holloway presented Ordinance 3812. Mrs. Holloway stated that the River District Capital Fund (418) was established in 2023 and has been used to manage all revenue and expenditures related to planned capital improvements to the River District and Whitewater Park development areas. She went on to say that the construction of the Whitewater Park and River District would take place over multiple years, with each development receiving funding from various sources that will be restricted for use within the earmarked development. She stated that it was her recommendation for the city to establish an independent fund for the Whitewater Park, to manage all received revenues and expenditures in a fund separate from the general development of the River District. She advised that if approved, the legislation will be sent to the State Auditor's office for formal approval.

Mayor Barnhart asked Council if there were questions or comments. There were none.

Mrs. Tomlin moved, seconded by Mr. Tilton, to approve Ordinance 3812. A vote was taken: Mr. Tilton-yes, Mrs. Tomlin-yes, Mrs. Williams, Mr. Boyle-yes, Mr. Dobson-yes, Mrs. Fryman-yes, and Mayor Barnhart-yes.

## REPORTS BY OFFICERS

City Manager Holloway advised that the City's annual resurfacing program would kick off next week on Wednesday, September 3<sup>rd</sup>. She listed the impacted streets and advised that "no parking" signs would be placed 72 hours before the resurfacing.

## S. Alex Road

Council discussed the S. Alex Road project, weighing the options of pursuing funding for a 3-lane reconfiguration (Option A) or maintaining the current 5-lane configuration (Option B). After a detailed discussion on both options, Council directed the City Manager to cease any pursuit of funding to modify the road from 5 lanes to 3. She verified that the plan was to resurface the road in its current configuration (5 lanes) in segments beginning in 2027. Council confirmed.
