Section 2: That there be and hereby is levied on the tax duplicate of said city the rate of each tax necessary to be levied within and without the ten-mill limitation, as set forth in "Schedule A" and "Schedule B", which are attached hereto and made a part hereof.

Section 3: That the clerk of this Council be directed to certify a copy of this Resolution to the Montgomery County Auditor.

Section 4: That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were adopted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 5: This resolution shall be in full force and effect from and after its date of passage.
