

## RECORD OF ORDINANCES

Ordinance No. 3826

### **AN ORDINANCE LEVYING SPECIAL ASSESSMENTS FOR THE LIGHTING OF STREETS, LANES AND OTHER PUBLIC WAYS IN THE CITY OF WEST CARROLLTON, OHIO WITH ELECTRIC LIGHTING.**

**WHEREAS**, the Council of the City of West Carrollton passed Resolution 20-2026, which declared the necessity of this lighting assessment.

#### ***NOW, THEREFORE, THE MUNICIPALITY OF WEST CARROLLTON, OHIO, HEREBY ORDAINS:***

**Section 1:** That the revised assessment of the cost and expense of the lighting of the streets, lanes and other public ways in the City of West Carrollton, Ohio with electric light during the year 2025 amounting in the aggregate to \$175,237.84 as reported to this Council on March 10, 2026 be and the same is hereby adopted and confirmed and there is hereby levied and assessed upon all lots and lands lying and being within the corporate limits of the city and those amounts reported as aforesaid, which assessments are in proportion to the tax value thereof and are not in excess of any statutory limitation.

**Section 2:** That this Council hereby finds and determines that the revised assessments as now on file in the office of the said clerk and are in the same proportion of the estimated assessments as originally filed.

**Section 3:** That the assessment against each lot or parcel of land shall be payable in cash within thirty (30) days after passage of this ordinance or at the option of the owner in one annual installment. All cash payments shall be made to the Finance Director of this City. All special assessments payments thereof remaining unpaid at the expiration of said thirty (30) days shall be certified by the Clerk of Council to the County Auditor as provided by the law to be placed by him on the tax duplicate and collected as other taxes are collected.

**Section 4:** That the Clerk of Council shall cause a notice of the passage of this ordinance to be published once in a newspaper of general circulation for two consecutive weeks and/or published of such notice on the web site of the municipal corporation and shall further retain on file in her office said revised assessments.

**Section 5:** The Clerk of Council is hereby directed to deliver a certified copy of this ordinance to the County Auditor after its passage.

**Section 6:** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with all legal requirements, including but not limited to Section 121.22 of the Ohio Revised Code.

**Section 7:** That this Ordinance shall take effect from and after the earliest period allowed by law.
