**A RESOLUTION AUTHORIZING THE SUBMITTAL OF A FY2026 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM APPLICATION TO REPLACE THE SWING SET STRUCTURE AND PLAY SURFACE AT WEIDNER PARK, AND AUTHORIZING THE CITY MANAGER TO REPRESENT THE CITY IN FULFILLING ALL PROGRAM REQUIREMENTS.**

**WHEREAS**, Montgomery County is currently soliciting applications for the FY2026 Community Development Block Grant (CDBG) funding cycle, with approximately \$800,000 available to communities, including the City of West Carrollton, whose CDBG funds are administered by the County; and

**WHEREAS**, the City of West Carrollton has the authority to apply for and to administer the amounts received from this program, and this project is believed to meet eligibility requirements for said funding by meeting at least one of the three National Objectives, specifically to principally benefit low-and moderate-income persons by providing accessible playground equipment which will expand equitable access to recreation opportunities for residents of all abilities and help ensure this busy playground best serves the community; and

**WHEREAS**, an eligible activity for the use of Community Development Block Grant (CDBG) funds is the provision of public services, including recreational needs; and

**WHEREAS**, the City of West Carrollton desires to submit an application seeking grant funds from the FY2026 Community Development Block Grant (CDBG) program administered by Montgomery County to replace the swing set and play surface at Weidner Park; and

**WHEREAS**, the City Council of the City of West Carrollton must direct and authorize the City Manager to act in connection with the application and to provide such additional information as may be required.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WEST CARROLLTON, OHIO:**

**Section I.** The City Manager, or her designee, be herewith authorized to act, and designated as the official representative of the City of West Carrollton, in conjunction with all aspects of the preparation, filing, provision of information, and submittal of documentation necessary for participation in the Federal Community Development Block Grant (CDBG) application and funding process, administered by Montgomery County, Ohio, all such activities being necessary to conduct certain infrastructure improvements at Weidner Park for the purpose of replacing the swing set structure and play surface within the Olde Downtown low to moderate income census tract for the provision of recreational needs.

**Section II.** The West Carrollton City Council hereby understands and agrees that participation in the Program will require compliance with program guidelines and assurances.

**Section III.** The Finance Director is authorized to establish any necessary accounts or funds, as required by law, to handle the funds associated with the administration and accounting for CDBG funds relating to the River District Redevelopment.
