**A RESOLUTION AUTHORIZING THE SUBMITTAL OF A NATUREWORKS GRANT APPLICATION WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES (ODNR) FOR THE REPLACEMENT OF A PARK SHELTER LOCATED AT HINTERMEISTER PARK AND A PARK SHELTER LOCATED AT WILSON PARK, AND AUTHORIZING THE CITY MANAGER OR HER DESIGNEE TO REPRESENT THE CITY IN FULFILLING ALL PROGRAM REQUIREMENTS.**

**WHEREAS**, the State of Ohio through the Ohio Department of Natural Resources administers financial assistance for public recreation purposes through the NatureWorks Grant Program; and

**WHEREAS**, the City of West Carrollton has the authority to apply for and to administer the amounts received from this program, and this project is believed to meet eligibility requirements for said funding; and

**WHEREAS**, the City of West Carrollton desires to apply for grant funds from the NatureWorks program administered by the Ohio Department of Natural Resources (ODNR) to purchase and replace a park shelter located at Hintermeister Park and park shelter located at Wilson Park; and

**WHEREAS**, the City Council of the City of West Carrollton must direct and authorize the City Manager to act in connection with the application seeking grant funds and to provide such additional documentation or information as may be required in the grant application process.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WEST CARROLLTON, OHIO:**

**Section 1:** The City Manager, or her designee, is hereby authorized to act and is designated as the official representative of the City of West Carrollton in conjunction with all aspects of the preparation, filing, provision of information, and submittal of documentation necessary for participation in the NatureWorks Grant application and funding process, administered by the Ohio Department of Natural Resources (ODNR), all such activities being necessary to conduct certain infrastructure improvements at Hintermeister Park and Wilson Park for the purpose of replacing two park shelters available to the citizens of West Carrollton for recreational use.

**Section 2:** The West Carrollton City Council hereby acknowledges that participation in the Program will require compliance with program guidelines and assurances.

**Section 3:** The Finance Director is authorized to establish any necessary accounts or funds, as required by law, to manage the funds associated with the administration and accounting for NatureWorks Grant funds.

**Section 4:** It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including, but not limited to Section 121.22 of the Ohio Revised Code.

**Section 5:** This resolution shall be in full force and effect from and after its date of passage.
